### Sheriff/Chief -

I spent some time this morning in A3 speaking to the inmates on the hunger strike. The nurse was going around getting their daily vitals/weight and I could tell they were going to start to refuse. I told them all that not eating was not going to get the SA or the Judge to change or reduce their bond. I also wanted to personally hear from them and let them air their grievances. I made it clear that the SA and Judges are aware of what is going on and the SA is keeping tabs on their phone calls. I told them that we know they are eating at times, which is good, but we need to get past their stance (hunger strike) for their own personal wellbeing. I told each of them that they have the right to remain on a hunger strike and I will not interfere with their choice to eat or not but I assured them their medical and mental health needs will remain our priority. They were told if they continue to deny food and the daily medical assessments, they will be moved to booking to be placed on medical checks for closer observation.

Their complaints as of this AM are as follows:

Dominic Fortune – He has been eating per the food log and was removed from the hunger strike. He stated the last thing he knew his attorney, Ed, was going to seek another fitness review before they moved on with his case but he doesn't think he needs it. He would like to speak with Ed but has not heard from him. He also feels he should have a reasonable bond and fight his case from the street.

Jacob Hill – He continues to refuse meals and remains with a sign in his window. He did get \$62.99 worth of commissary and \$33.71 worth of fresh food last week. He agreed to have his vitals and weight taken while I was speaking with him. The nurse noticed he came out for his weight in just his boxers and not a full uniform. He did accept 3 meals last Thursday into Friday but stopped again at supper. He feels he has been here a very long time with no movement on his case. He said he just fired his attorney and was reassigned the PD. I told him that changing attorneys will push hearings back because the new attorney will have to be caught up. He stated he has been offered 4½ but and 4 yrs parole time but that is too much because he needs to get out and see his child. He said he has a 1 year child that he has not seen because he has been locked up. I told him that it sounds like he has many reasons to be eating and taking care of himself. He also said he has been provided a treatment plan option via Rosecrance and he would like to be able to seek help instead of incarceration. He would like time with his new PD.

Malcom McGee – According to the food logs he has been off and on again with his meals. He also received \$88.95 worth of commissary on 3/01. He has received medical assessments the last several days. When I attempted to speak with him and provide him a moment to talk, he was argumentative, unhappy and didn't appear to want any assistance. I told him I was there to hear from him but I was not going to force anything out of him or assist him if he doesn't want any help. As I started to leave, he started to calm down and open up. He stated he has had PD Lepp and cannot get a response or call from her. He said he wants a new attorney or at least someone to work on his case. He feels he has ineffective counsel and no one in his corner to assist him with his case. He claims to have filled out his own motions with no help from his attorney. He is also asking to speak to a PD/attorney.

Richard Frazier – Mr. Frazier is roommates with Mr. McGee. He was very polite and respectful while speaking with me. He originally refused to have his vitals and weight taken but changed his mind. He is another one that has been off and on again per the food logs. He still states he is on a hunger strike. He received \$56.99 worth of commissary on 3/01. He is attending 2 programs and seems to enjoy them. He is really struggling with his attorney and the lack of representation. He said he was assigned to PD Lepp and has had zero response or interactions with her. He feels his bond is very high for his charge. He would like time with the PD/attorney.

Troy Carter – Mr. Carter was at his window when I went to speak to Mr. Hill. He removed himself from the hunger strike a few days ago but wanted to speak to me about his lengthy time in jail. He was very pleasant and respectful during our conversation. He received \$114.23 in commissary on 3/01 and received FF and commissary yesterday. He stated he has a private attorney and his case is not moving. He is willing to hear an offer to get things moving.

Landon Hinkle - Mr. Hinkle was open to talking but didn't have much to say as to why he was on a hunger strike. He said he attempted to speak to Detective Sprague yesterday but it didn't go well. He wanted to provide him some documentation but Detective Sprague would not take it or listen. He said he hasn't spoken to an attorney yet and is not sure who he was assigned to. Mr. Hinkle had no extra food in his cell or money on his acct for commissary. He appreciated me checking on him and was willing to provide a weight and eat lunch.

John Clay - According to food logs, Mr. Clay has been off and on again with his meals. He doesn't appear to have any extra food in his cell. He claims to have no money for commissary. Mr. Clay is very upset about his lack of representation from PD Lepp. He feels he needs to see the psychiatrist and start his mental health meds again. He stated he has a learning disability and past diagnosis of bipolar disorder. He believes medication could help him with his decision making and make him feel better. He also feels his bond is very high so has no option to post the bond. Mr. Clay misses his family and child and would like to get his case resolved. He is also asking to speak to an attorney.

Clifford Like – Mr. Like is a new member to the hunger strike team as of 3/04/2023. Mr. Like is an angry man that feels the justice system is a complete failure. He has a clear dislike for authority and those that wear a uniform. He was very agitated upon my arrival to A3. His voice was raised, talking over the TV, so everyone could hear him. He was out on his recreation when I asked to speak to him. He stated he would like to complete his video visit first. I told him he would need to calm down and speak to me in a lower voice. He stated he was upset over an incident that happened back in January 2023. He stated he got into a fight with his cell mate and that Officer McMahon attempted to tase him. He said the taser missed him but he was not resisting at the time. He was very upset that he was tased (attempt) and feels it was an excessive use of force. He was animated in his description of the fight and response by Officer McMahon. He said he was now being charged with aggravated battery because of the fight. I told him that he can not fight in jail because it could result in a charge just like on the street. He understood but was more upset with Officer McMahon and all the Lts that responded to his grievance and appeal. I told him I would review the video footage, report and provide my feedback. I told him he should not expect a response tomorrow since it will take me time to review. It was clear he was not willing to listen to much that I had to say but I did let him air his grievance. I am not 100% clear if he is not eating from the incident in January or not.

Please understand that I am only reporting their concerns with their attorneys, bonds, charges and have no information to back their complaints. I am passing this information on so you are all aware of my interactions with the group and where we stand today.

### As it stands right now:

Mr. Frazier remains on hunger strike but compliant with medical assessments and remains in A3.

Mr. Hill remains on the hunger strike, refused lunch but did allow a medical assessment. He will be moved to booking for closer observation due to the lack of food intake per the food log and Mr. McGee remains on the hunger strike and refused the medical assessment. He has refused the past 4 medical assessments. He will be moved to booking for a close observation.

Mr. Like remains on a hunger strike that he just started on 3/04/2023. He will be moved to booking for closer observation due to the lack of food per the food log and refusal to be assessed by medical staff.

SA's are included for their continued legal guidance with this matter.

While we have dealt with issues of quality in the past, which were immediately addressed, the recent RFP was issued as a result of Aramark's unwillingness to adhere to the current contract. If you have facts leading to another conclusion, please let me know so it can be addressed ASAP.

As I'm sure you've come to expect, I can guarantee you there is no unethical or illegal treatment going on in the jail.

Across the board, the answer was essentially the same, and it was that they do not like the rec schedule, they disagree with housing, they all want their bonds reduced because their 8<sup>th</sup> Amendment rights are being violated, and they will only eat or drink if they are given house arrest. The only one who had anything different to say was who stated he looked it up online and somewhere he saw that his offense had a house arrest option. His reasoning was somewhat nonsensical, and when asked questions about his stance, he did not have much to say outside of citing the 8<sup>th</sup> amendment. All denied any mental heath distress or need.





We continue to document food intake or refusals on a food log. Medical staff is required to complete vitals and get a weight on them daily. Lt. Good will be reviewing their food log with medical every day. The Nurse Practitioner will be consulted everyday so she is apprise of any changes. I also put out an email to everyone (kitchen staff, medical, officers, mental health) reminding them to document everything. If they receive any extra food via commissary or fresh food it should be documented plus we will have a signed receipt. I have been provided all of their commissary/FF orders for the month of February so most of them have something to eat.

I want you all to know that Dominic Fortune has claimed a hunger strike for this specific reason on several occasions but discontinues on this own after a few days. He also was very unhappy with his PD at the time and waited to take a stance to get the SA and Judges attention. It appears he has made an impression on the others in his housing unit. I am not surprised by the ones that joined him after viewing the names. They have been problematic inmates either here or while in Kankakee and brought back.

Our MH clinician met with them on Sunday to ensure they were not suicidal or having a mental health breakdown and they all had the same reason for declaring a hunger strike which matched Fortunes previous complaints. They complained about their recreation schedule and their housing, they all want their bonds reduced because their 8<sup>th</sup> amendment rights are being violated and they will only eat or drink if they are given house arrest.

I wonder if their PD or someone from the PD's office spoke to the group maybe they would understand this is not the way to get the SA/Judge's attention and they will not be released on a bracelet. Just an idea.

I did not include the Judge or the PD in the email until I received your thoughts.

Subject: Hunger Strike Update

Sheriff/Chief -

I spent some time this morning in A3 speaking to the inmates on the hunger strike. The nurse was going around getting their daily vitals/weight and I could tell they were going to start to refuse. I told them all that not eating was not going to get the SA or the Judge to change or reduce their bond. I also wanted to personally hear from them and let them air their grievances. I made it clear that the SA and Judges are aware of what is going on and the SA is keeping tabs on their phone calls. I told them that we know they are eating at times, which is good, but we need to get past their stance (hunger strike) for their own personal wellbeing. I told each of them that they have the right to remain on a hunger strike and I will not interfere with their choice to eat or not but I assured them their medical and mental health needs will remain our priority. They were told if they continue to deny food and the daily medical assessments, they will be moved to booking to be placed on medical checks for closer observation.

Their complaints as of this AM are as follows:

Dominic Fortune – He has been eating per the food log and was removed from the hunger strike. He stated the last thing he

knew his attorney, Ed, was going to seek another fitness review before they moved on with his case but he doesn't think he needs it. He would like to speak with Ed but has not heard from him. He also feels he should have a reasonable bond and fight his case from the street.

Jacob Hill – He continues to refuse meals and remains with a sign in his window. He did get \$62.99 worth of commissary and \$33.71 worth of fresh food last week. He agreed to have his vitals and weight taken while I was speaking with him. The nurse noticed he came out for his weight in just his boxers and not a full uniform. He did accept 3 meals last Thursday into Friday but stopped again at supper. He feels he has been here a very long time with no movement on his case. He said he just fired his attorney and was reassigned the PD. I told him that changing attorneys will push hearings back because the new attorney will have to be caught up. He stated he has been offered 4 ½ yrs DOC and 4 yrs parole time but that is too much because he needs to get out and see his child. He said he has a 1 year child that he has not seen because he has been locked up. I told him that it sounds like he has many reasons to be eating and taking care of himself. He also said he has been provided a treatment plan option via Rosecrance and he would like to be able to seek help instead of incarceration. He would like time with his new PD.

Malcom McGee – According to the food logs he has been off and on again with his meals. He also received \$88.95 worth of commissary on 3/01. He has received medical assessments the last several days. When I attempted to speak with him and provide him a moment to talk, he was argumentative, unhappy and didn't appear to want any assistance. I told him I was there to hear from him but I was not going to force anything out of him or assist him if he doesn't want any help. As I started to leave, he started to calm down and open up. He stated he has had PD Lepp and cannot get a response or call from her. He said he wants a new attorney or at least someone to work on his case. He feels he has ineffective counsel and no one in his corner to assist him with his case. He claims to have filled out his own motions with no help from his attorney. He is also asking to speak to a PD/attorney.

Richard Frazier – Mr. Frazier is roommates with Mr. McGee. He was very polite and respectful while speaking with me. He originally refused to have his vitals and weight taken but changed his mind. He is another one that has been off and on again per the food logs. He still states he is on a hunger strike. He received \$56.99 worth of commissary on 3/01. He is attending 2 programs and seems to enjoy them. He is really struggling with his attorney and the lack of representation. He said he was assigned to PD Lepp and has had zero response or interactions with her. He feels his bond is very high for his charge. He would like time with the PD/attorney.

Troy Carter – Mr. Carter was at his window when I went to speak to Mr. Hill. He removed himself from the hunger strike a few days ago but wanted to speak to me about his lengthy time in jail. He was very pleasant and respectful during our conversation. He received \$114.23 in commissary on 3/01 and received FF and commissary yesterday. He stated he has a private attorney and his case is not moving. He is willing to hear an offer to get things moving.

Landon Hinkle – Mr. Hinkle was open to talking but didn't have much to say as to why he was on a hunger strike. He said he attempted to speak to Detective Sprague yesterday but it didn't go well. He wanted to provide him some documentation but Detective Sprague would not take it or listen. He said he hasn't spoken to an attorney yet and is not sure who he was assigned to. Mr. Hinkle had no extra food in his cell or money on his acct for commissary. He appreciated me checking on him and was willing to provide a weight and eat lunch.

John Clay – According to food logs, Mr. Clay has been off and on again with his meals. He doesn't appear to have any extra food in his cell. He claims to have no money for commissary. Mr. Clay is very upset about his lack of representation from PD Lepp. He feels he needs to see the psychiatrist and start his mental health meds again. He stated he has a learning disability and past diagnosis of bipolar disorder. He believes medication could help him with his decision making and make him feel better. He also feels his bond is very high so has no option to post the bond. Mr. Clay misses his family and child and would like to get his case resolved. He is also asking to speak to an attorney.

Clifford Like – Mr. Like is a new member to the hunger strike team as of 3/04/2023. Mr. Like is an angry man that feels the justice system is a complete failure. He has a clear dislike for authority and those that wear a uniform. He was very agitated upon my arrival to A3. His voice was raised, talking over the TV, so everyone could hear him. He was out on his recreation when I asked to speak to him. He stated he would like to complete his video visit first. I told him he would need to calm down and speak to me in a lower voice. He stated he was upset over an incident that happened back in January 2023. He stated he got into a fight with his cell mate and that Officer McMahon attempted to tase him. He said the taser missed him but he was not resisting at the time. He was very upset that he was tased (attempt) and feels it was an excessive use of force. He was animated in his description of the fight and response by Officer McMahon. He said he was now being charged with aggravated battery because of the fight. I told him that he can not fight in jail because it could result in a charge just like on the street. He understood but was more upset with Officer McMahon and all the Lts that responded to his grievance and appeal. I told him I would review the video footage, report and provide my feedback. I told him he should not expect a response tomorrow since it will take me time to review. It was clear he was not willing to listen to much that I had to say but I did let him air his grievance. I am not 100% clear if he is not eating from the incident in January or not.

Please understand that I am only reporting their concerns with their attorneys, bonds, charges and have no information to back their complaints. I am passing this information on so you are all aware of my interactions with the group and where we stand today.

Mr. Frazier remains on hunger strike but compliant with medical assessments and remains in A3.

Mr. Hill remains on the hunger strike, refused lunch but did allow a medical assessment. He will be moved to booking for closer observation due to the lack of food intake per the food log and his

Mr. McGee remains on the hunger strike and refused the medical assessment. He has refused the past 4 medical assessments. He will be moved to booking for a close observation.

Mr. Like remains on a hunger strike that he just started on 3/04/2023. He will be moved to booking for closer observation due to the lack of food per the food log and refusal to be assessed by medical staff.

SA's are included for their continued legal guidance with this matter.
